Detailed Reviewer's Report

- The abstract seems to be lacking what the paper intends to do and what methodology will be adopted. This clearly needs to be highlighted within the abstract.
- The objective seems to be repetitive; all four points can be clubbed into one major point as its intended seems to be the same.
- In research question part, Q.No. 3 where it's mentioned that are tribal women aware of government schemes/programme being implemented for their empowerment?, and then in Q.No. 4 its asked that are tribal women interested in micro entrepreneurship. Both these questions can be combined as it way of intention is both
- Minor grammatically errors were observed particularly in the hypothesis
- The conclusion of the paper needs to be more elaborate where the author needs to inference both the existing literature and their results and form a comparative way forward.
- The author needs to define the meaning of tribal and what does tribal in today's context mean as it's nowhere mentioned within the paper. Also it seems to be lacking which tribal community the author is talking about; as in Indian context tribal communities are of various domicile – it needs to be clearly mentioned which part of the country the author has done the study and also why did they selected only that particular tribe.
- The data that is mentioned clearly needs to highlight if it's from secondary sources or the author has done some in-field work from which the info is finally collaborated. The parameters of study needs to be described.
