A comparison between Islamic military jurisprudence and secular/multinational military doctrines (e.g., NATO ethics codes or International Humanitarian Law) would enhance the global relevance of the work.

#### 3. Insufficient Critical Engagement:

The study occasionally lacks a critical lens—especially when addressing sensitive themes like jihad. Greater emphasis on contesting interpretations, evolving doctrines, and contemporary geopolitical sensitivities would provide depth.

### 4. Contextual Limitation:

While Malaysia is a natural focal point, some findings and discussions are overly Malaysiacentric, potentially narrowing the broader applicability of the study's conclusions.

#### 5. Minor Language and Structural Issues:

There are occasional grammatical inconsistencies, redundant phrases, and repetitive transitions that could be refined to enhance clarity and academic tone.

#### Significance of the Study

This research is particularly significant for scholars in Islamic studies, military ethics, security policy, and strategic defense. By offering a faith-based framework for understanding military conduct, the paper contributes to the growing body of literature advocating ethical and values-driven military institutions.
