The inclusion of clinical and animal model references strengthens the scientific foundation. National data from NDUS 2019 offers a strong epidemiological context, and the demographic breakdown enhances the pertinence of the issue in the Indian context. Overall, the introduction sets a strong premise for the necessity and relevance of the study.

### Scientific and Methodological Rigor:

The study employs a cross-sectional design, which is appropriate for estimating prevalence and identifying associations. The sampling method is described as simple random sampling, enhancing the validity of the findings. The sample size of 125, though modest, appears justified within the context provided. The use of validated tools such as the AUDIT and the Obsessive-Compulsive Drinking Scale enhances the credibility of the data collection process. Ethical procedures, including informed consent, are noted, aligning the study with standard research protocols.

### Results Presentation and Interpretation:

The results are clearly presented with quantified classifications of alcohol use based on AUDIT scores. The reporting of 72.8% as alcohol dependent is a significant finding, and the breakdown of drinking patterns adds valuable granularity. The identification of socio-demographic factors (age, income, marital status) as statistically associated with dependence is well articulated. Mention of additional associations such as alcohol craving, obsession, compulsion, and stigma further enriches the findings. The data is presented in a logical manner, and the interpretation aligns with the stated objectives.
