- 1. **Timely and Relevant Topic:** The manuscript deals with contemporary feminist discourse in Islamic scholarship, addressing the intersection of Sufism, gender, and hermeneutics—a unique and underexplored niche.
- 2. **Comprehensive Theoretical Engagement:** The paper provides a rigorous synthesis of Sa'diyya Shaikh's works and her interpretation of Ibn 'Arabi's concept of al-insān al-kāmil and spiritual parity.
- 3. **Strong Qualitative Foundation:** The use of content analysis and secondary literature is methodologically sound and reflects an in-depth engagement with primary sources.
- 4. **Critical Deconstruction of Islamophobic Narratives:** The article successfully challenges dominant Western portrayals of Muslim women by providing an indigenous and scholarly rebuttal.

5. **Well-Supported Arguments:** Claims are supported with a strong theoretical foundation, including references from feminist Islamic scholars such as Barlas, Wadud, and Mir-Hosseini.

Weaknesses:

- 1. **Limited Critical Distance:** The paper could benefit from more critical distance in evaluating Shaikh's interpretation of Ibn 'Arabi rather than adopting it fully as normative.
- 2. **Over-Reliance on Secondary Sources:** The analysis is heavily dependent on Shaikh's published works; it would be enriched by incorporating more diverse voices or contemporary critiques.
- 3. **Minimal Engagement with Counter-Arguments:** Traditional Islamic perspectives critical of feminist hermeneutics are only briefly mentioned and dismissed without thorough engagement.
- 4. **Dense Theoretical Language:** At times, the writing is overly academic and inaccessible to non-specialist readers. Simplifying some passages would improve clarity.
- 5. Lack of Methodological Transparency: The qualitative design is mentioned but not elaborated in detail. A brief methodological framework (e.g., inclusion criteria or analytical lens) would strengthen the paper.
