Strengths

- 3. Up-to-date and reliable data: The use of 2022–2023 sources (e.g., IPCC, IEA, World Bank) supports credibility and accuracy.

- 4. Comprehensive thematic coverage: The paper integrates vulnerability, energy, and justice perspectives in a balanced manner.
- 5. Clear and actionable recommendations: Proposed solutions—finance, technology transfer, and multilateral support—are well grounded.

Weaknesses

- a) Incomplete references in the literature review : Several citations show "(author?)", which reduces scholarly rigor and must be corrected.
- b) Underdeveloped methodology section: The methodology lacks detailed justification of data sources and analytical strategy.
- c) No empirical case studies: The analysis remains conceptual; local-level examples would strengthen the real-world connection.
- d) Limited discussion of domestic resistance: Internal political and economic barriers to transition are underexplored.
- e) Occasional descriptive tone : Some sections lean toward description rather than critical analysis or argumentation.

Recommendation: minor revisions;

- 1) Fixing citation and attribution errors,
- 2) Expanding the methodology discussion,
- 3) Possibly adding empirical insights or a case example.
