- 1. **Extensive Sampling Framework:** The study draws data from 10 states/UTs with responses from over 29,000 participants, including multiple stakeholder groups. This large and diverse sample enriches the generalizability of the findings.
- 2. **Policy-Relevant Focus:** The research aligns closely with national digital initiatives such as DIKSHA, PM e-Vidya, SWAYAM, and NISHTHA, offering evaluative feedback critical for educational policy development.
- 3. **Mixed-Methods Design:** Combining quantitative surveys with interviews, the study provides depth to the analysis and accommodates multiple perspectives on quality and sustainability.
- 4. **Timeliness and Practical Utility:** The topic is highly relevant in the post-pandemic educational landscape, and the findings offer direct implications for future digital and hybrid learning practices.
- 5. **Strong Thematic Organization:** The manuscript maintains coherence through clearly defined sections, importance of sustainable learning, stakeholder roles, national initiatives, and challenges, thus aiding readability.

Weaknesses:

- 1. Language and Syntax Issues: Several grammatical errors, awkward phrasings, and typographical inconsistencies exist throughout the manuscript and require proofreading for smoother academic expression.
- 2. **Overloaded Figures and Data Tables:** Graphs and percentages are at times excessive and crowd the narrative. Consider summarizing or moving them to appendices for improved flow.
- 3. Conceptual Clarity Needs Improvement: While the paper talks about "sustainability of learning," the operational definition of this construct is vague and underdeveloped in terms of measurable indicators.
- 4. **Literature Review Needs Strengthening:** The literature cited is somewhat generic in parts. A tighter focus on recent Indian and comparative global studies would strengthen the foundation.
- 5. **Stakeholder Voices Could Be Richer:** Though responses are numerically presented, qualitative reflections from interviews (e.g., quotes or thematic patterns) could enrich the interpretation.
