#### Detailed Reviewer's Report

The article explores the Bangkok Treaty of 1909 as a pivotal event that initiated British colonial domination over the northern Malay States, presenting it as a strategic imperial move rather than a mere diplomatic agreement. Through an extensive literature review drawing from both traditional and postcolonial sources, the author demonstrates how the treaty redefined power dynamics in Southeast Asia by expanding British influence and curtailing Siamese control over key territories. The review's major strengths lie in its choice of a focused and regionally significant topic, comprehensive engagement with diverse scholarly interpretations, effective historical contextualization, and clear, accessible language. The article situates the treaty within broader frameworks of colonial administration and international diplomacy, enhancing the reader's understanding of its long-term impact. However, the article lacks deeper analytical engagement with its sources and misses the opportunity to frame the discussion within a defined theoretical perspective such as imperialism or treaty law. Additionally, reliance on older sources limits the review's relevance in contemporary academic debates, and the conclusion, though summarizing the core argument, fails to reflect on the treaty's modern implications for Malaysia-Thailand relations or regional identity. To strengthen the work, the author should incorporate more recent literature, compare scholarly disagreements more explicitly, adopt a critical tone when evaluating historical interpretations, and expand the conclusion to address the treaty's lasting legacy. Overall, the article is well-structured, informative, and timely, and it makes a significant contribution to the field of Southeast Asian colonial history. With minor revisions aimed at improving analytical depth and academic framing, it is well-suited for publication and will serve as a valuable resource for researchers and students interested in historical treaty politics, British imperialism, and the transformation of political boundaries in colonial Southeast Asia.
