The explanation of the eight coping dimensions—Impunitive, Intrapunitive, Extrapunitive, Defensiveness, Impersistive, Intrapersistive, Extrapersistive, and Interpersistive—adds depth, along with the classification of the first four as avoidance-oriented and dysfunctional in the Indian context. The research objective is well stated, focusing on determining the psychometric properties of the instrument. The mention of statistical analyses, including internal consistency, construct validity, exploratory factor analysis, and reliability testing, confirms the empirical foundation of the work. Overall, the abstract successfully encapsulates the study's scope, methodology, and significance.
