Epidemiological data regarding incidence and age distribution is clearly presented, alongside diagnostic criteria involving imaging modalities and histopathology. The section effectively situates the rarity and clinical importance of the presented case within existing literature on uterine sarcomas.

Case Presentation Evaluation:

The case presentation is detailed and systematically narrated. The patient profile—a young, nulliparous woman in her late thirties—is clearly introduced, with attention to presenting complaints such as heavy menstrual bleeding, abdominal pain, and a palpable mass. Clinical examination findings, including ECOG performance status, hemoglobin status, and abdominal as well as pelvic examination features, are precisely documented.

The diagnostic workup is described in depth. Ultrasound findings indicate a bulky uterus with fibroid, while contrast-enhanced CT scan demonstrates an enlarged anteverted uterus with a heterogeneous posterior myometrial lesion, a smaller fundal lesion, and mass effect on adjacent bowel loops. The report also notes multiple hypodense lesions in the liver, raising suspicion of metastatic spread. The documentation of lesion sizes, anatomical relationships, and radiological characteristics enhances diagnostic clarity and clinical relevance.
