Evaluation:

• Originality: Good

The paper addresses an underexplored issue by linking human health and livestock productivity impacts of brucellosis in Uganda, providing region-specific insights that are valuable for policymakers and researchers.

• Technical Quality: Good

The methodology is sound, employing both primary and secondary data with disability-adjusted life years (DALYs) and economic loss models. However, the study would benefit from clearer justification of assumptions (e.g., disability weights, exclusion of fatalities in DALY calculation).

• Clarity: Good

The paper is generally well-structured, with clear sections on methods, results, and discussion. Nonetheless, certain parts (especially results tables and economic models) could be presented more concisely with better formatting for readability.

• Significance: Excellent

The study demonstrates strong practical relevance by quantifying both household-level economic losses and public health implications, making it useful for stakeholders in health, veterinary services, and policy planning.

Strengths:

- 1. Addresses a neglected zoonotic disease in a post-conflict setting, filling an important research gap.
- 2. Combines socio-economic, epidemiological, and health metrics, providing a holistic perspective.
- 3. Offers practical policy implications for disease control and poverty alleviation.

Weaknesses & Suggestions for Improvement:

- 1. **DALY Estimation** Since mortality data was unavailable, results may underestimate the true burden. Authors should acknowledge this limitation more explicitly.
- 2. **Economic Analysis** The economic loss models are strong but could be improved by discussing sensitivity to market price fluctuations.
- 3. **Policy Recommendations** While the conclusion emphasizes awareness and control, the paper could strengthen its impact by proposing specific community-level interventions or government strategies.
- 4. **Editing** Minor language corrections and reduction of repetitive statements in the discussion section would improve readability.
