The unanimous village finding that caste drives voting reinforces national evidence. Ultimately, aspirations rise and caste salience softens when inclusive policies expand exposure, representation, and transparent access to opportunities.

Reviewer's Comment / Report

The paper titled "How Caste-Based Identities Shape Economic Aspirations and Political Alignment in India." synthesizes evidence on caste's influence on India's economic aspirations and political alignment, using a literature review and a pilot survey of 33 villagers (all affirming caste's role in voting). It explores caste's impact on education, occupation, migration, and political behavior, mediated by policies like reservations. Strengths: robust theoretical grounding, policy relevance; weaknesses: small, non-representative sample, limited primary data. Overall, a compelling overview advocating for transparent welfare and inclusive education, needing larger-scale empirical validation.

Suggestions for Improvement:

- 1. The introduction could better highlight the novelty of this study (what gap it fills relative to existing literature).
- 2. t might also outline how the paper integrates the literature review, framework, and pilot evidence into a coherent argument.
- 3. The review sometimes summarizes rather than critically synthesizes.
- 4. More explicit discussion of contradictions in the literature (e.g., convergence vs persistence; descriptive vs substantive representation) would strengthen the analysis.
- 5. The framework could be visually represented (diagram/figure) for clarity.
- 6. It would also benefit from hypothesized relationships or testable propositions, which could guide future empirical research.
- 7. The Methods section could detail sampling bias risks (e.g., why this particular village, potential social desirability bias in unanimous responses).
- 8. Including more qualitative quotes from respondents would enrich understanding beyond the yes/no result.
- 9. Findings could be expanded with frequency counts (e.g., how many cited each reason) or illustrative verbatim quotes.
- 10. The discussion could explicitly address alternative explanations (e.g., regional political culture, class factors intertwined with caste).
- 11. Could include feasibility considerations e.g., challenges in implementing transparent welfare systems in weak-capacity settings
