3. Major Concerns

1. Language and Grammar

- Multiple typographical errors (e.g., "CERVICAFACIAL," "CONFLIT OF INTEREST," "guidlines").
- o Sentences occasionally lack clarity and should be edited for smooth flow.

2. Structure and Formatting

- Abstract is presented in bullet-like format; restructure into a concise narrative (Background, Case, Conclusion).
- o Redundant headings (Introduction appears twice) should be removed.
- o Figures need legends with resolution and patient-consent statements.

3. Clinical/Scientific Detail

- Timeline of disease progression and dental interventions could be more precise (dates, number of visits).
- Laboratory work-up beyond peripheral smear (imaging, bone marrow aspirate, cytogenetics) not described.
- Discussion could further contrast this case with similar reports and elaborate on differential diagnoses.
