Reviewer's Comment for Publication

However, a few minor revisions are recommended before publication:

- 1. **Abstract Refinement** The abstract is informative but could be tightened for coherence and conciseness. A clear research gap and thesis statement should be emphasized.
- 2. **Methodology Clarification** The methodology section is present but brief. Clarifying how textual analysis was conducted (e.g., selection of key scenes, coding of themes) will improve academic rigor.
- 3. **Citation Consistency** In-text citations vary in style (sometimes missing years or page numbers). Standardizing MLA/APA formatting throughout is necessary for scholarly presentation.
- 4. **Grammar and Language Polishing** A few awkward sentences and typographical issues exist (e.g., spacing errors, missing articles, and repetitive phrasing).
- 5. **Conclusion Strengthening** The conclusion is insightful but could benefit from explicitly restating the study's contribution to trauma studies or wartime medical narratives.

Final Evaluation:

This paper makes a meaningful and scholarly contribution to contemporary trauma literature and war fiction analysis. With **minor revisions**, it will be suitable for publication in a literary or interdisciplinary humanities journal.
