This study addresses an urgent health issue with a sound methodological approach and provides valuable insights into childhood obesity in Kerala. However, it requires significant revisions to improve clarity, organization, and scientific rigor before publication.

### Reviewer's Comment / Report

### **Strengths:**

- 1. **Relevant Topic:** The study addresses an important public health issue—childhood obesity—which is increasingly prevalent worldwide and particularly significant in India.
- 2. Clear Objectives and Hypotheses: The research clearly states its objectives and hypotheses, providing a focused framework for investigation.
- 3. **Methodology:** Utilizes a descriptive cross-sectional survey design suitable for prevalence studies. The sample size (300 mothers) is adequate for the objectives, and inclusion/exclusion criteria are well defined.
- 4. **Data Collection Instruments:** The use of standardized tools such as the Family Planning Nutrition Assessment (FNPA) enhances data reliability.
- 5. **Identification of Key Risk Factors:** The study highlights junk food consumption as significantly associated with obesity risk, aligning with existing literature.
- 6. **Discussion of Implications:** It offers practical recommendations for nursing practice, education, and administration, emphasizing preventive strategies.

#### Weaknesses:

- 1. **Structural and Formatting Issues:** The document's formatting appears inconsistent, with pages numbered and headings that interrupt the flow of reading. Some sections (e.g., introduction, methods) could be better organized.
- 2. Language and Grammar: There are several grammatical mistakes and typographical errors, e.g., inconsistent tense usage ("most children had moderate risk" vs. "most children showed a moderate risk"), and awkward sentence constructions that hinder clarity.
- 3. **Incomplete Data Presentation:** While associations are discussed, detailed statistical data (e.g., confidence intervals, exact p-values) are sparse, limiting the assessment of the robustness of findings.
- 4. **Limited Analysis of Variables:** The study highlights junk food consumption but does not sufficiently analyze other potential factors like physical activity, socioeconomic status, or genetic predisposition.
- 5. **Inconsistencies in References:** The referencing style appears inconsistent, with some references missing complete bibliographic details or proper formatting.
- 6. **Lack of Visual Data Aids:** The inclusion of tables, figures, or graphs summarizing key findings would improve data interpretation.
