1. **Title:** The phrase "Killer picket in carpenter" is ambiguous and may not reflect the medical content accurately. Consider rephrasing for clarity, e.g., "A Rare Case of Acute Pyelonephritis Leading to Acute Kidney Injury in a Young Male."

- 2. Language and Grammar: Minor grammatical errors and inconsistent capitalization should be corrected for smoother readability.
- 3. **Abstract:** Could be slightly expanded to include management outcomes and highlight the link to undiagnosed diabetes.
- 4. **Figures and Tables:** Ensure all figure captions and table headings are consistently formatted (e.g., Figure 1A–C).
- 5. **Discussion:** While comprehensive, it can be condensed slightly to maintain focus on the novelty and clinical implications.
- 6. **References:** Maintain consistent referencing style (uniform spacing and punctuation).

The manuscript provides an informative and rare clinical insight into acute pyelonephritis as the first presentation of diabetes in an adolescent. With minor editorial improvements and refinement of the title, it is suitable for publication.
