1. Strengths of the Manuscript

2. Weaknesses / Limitations

References missing at many places—several statements are unsupported by citations

The manuscript is too long and contains unnecessary repetition, especially in:

historical background

Unani actions

morphology section

Formatting errors (line breaks, spacing, abrupt headings).

No defined methodology for the review, e.g., search strategy, inclusion/exclusion criteria.

Language issues—long sentences, grammatical inconsistencies, and lack of academic tone in some parts.

Many Unani terms are not explained clearly for non-Unani readers.

Pharmacological section is descriptive only, not critically analysed.

No tables summarizing pharmacological studies, which weakens scientific clarity.

No discussion section summarizing gaps, limitations, and future scope.

No clear conclusion linking all the evidence together.

Excessive textual details (e.g., microscopic features) without diagrams or concise tabulation.
