Reviewer's Comment for Publication

While the topic is timely and the discussion is well-informed, the paper is primarily **descriptive and policy-review based**, with limited original empirical or analytical contribution. As such, it requires **minor revisions** to improve academic rigor, clarity.

Detailed Reviewer's Report

1. Scope & Relevance

- The topic of digital inclusion, especially in social housing, is highly relevant to contemporary social policy, housing studies, and digital equity research.
- The scope is clearly defined and consistently maintained throughout the paper.

2. Structure & Technical Presentation

- The paper is well-structured with clear sections: introduction, drivers, consequences, policy responses, and conclusions.
- Tables are relevant and informative.
- Figures are referenced, but **visual clarity and captions should be improved.**
- Some formatting inconsistencies exist (spacing, line breaks, bullet alignment).

3. Methodological / Analytical Details

- The study does not present original empirical data or a formal research methodology.
- It relies on secondary sources, policy evaluations, and pilot program reports.
- While acceptable as a **review/policy analysis paper**, this should be more explicitly stated.
- A brief section clarifying the **methodological approach (narrative review / policy synthesis)** would strengthen transparency.

4. References & Citations

- References are recent (mostly 2020–2024) and relevant.
- Sources include reputable academic journals, government bodies, and policy organizations.
- Citation style is mostly consistent; though **minor formatting corrections** are needed.
- The balance between academic and grey literature is appropriate for the topic.

5. Language & Style

- The language is clear, readable, and accessible.
- Minor grammatical issues, spacing errors, and informal phrasing appear in a few sections.

REVIEWER'S REPORT

- Some sentences are overly long and could be simplified for academic clarity.

6. Key Strengths

- Timely and socially significant topic.
- Comprehensive synthesis of current policy initiatives and pilot programs.
- Clear linkage between digital exclusion and broader inequalities (health, education, employment).
- Strong conclusion with actionable policy-oriented recommendations.
- Well-supported arguments using up-to-date evidence.

7. Areas for Improvement (Minor Revision Needed)

- Explicitly clarify the **nature of the paper** (policy review / narrative synthesis).
- Write the conclusion part.
- Improve figure quality and ensure all tables and figures are clearly formatted.
- Reduce repetition in policy discussion sections.
- Strengthen academic tone by tightening long sentences.
- Address minor formatting and spacing inconsistencies throughout the manuscript.

Final Feedback to Author

This manuscript makes a valuable contribution by synthesizing recent evidence on digital exclusion in social housing and framing digital access as a rights-based housing issue. The paper is well-written, relevant, and supported by current literature, but it would benefit from minor revisions to improve presentation, methodological clarity, and academic precision. With these refinements, the manuscript would be suitable for publication.
