## CASE STUDY : RESOLUTION OF A CHRONIC NON-HEALING SURGICAL WOUND WITH CALCAREA CARBONICA

### Abstract

This case study presents the successful homeopathic management of a chronic non-healing surgical wound in a 43-year-old female Mrs. S.N. using Calcarea Carbonica 0/1. The wound, located on the upper back, (operated for trapezoid and rhomboid muscle tumor) persisted for over two years despite conventional wound care and antibiotic therapy. The case highlights the individualized remedy selection based on constitutional and local symptoms, and the observed clinical improvement over a 10-week period.

### Introduction:-

#### Presenting Complaints:

- Persistent open wound with serous discharge.
- Surrounding skin induration and mild erythema.
- Occasional itching and burning sensation.
- Emotional distress due to chronicity.
- Cosmetic concerns, people looking at her.
- Slow wound healing tendency.

#### Diagnostic Workup:

- **Wound Culture:** No active infection; colonization with Staphylococcus epidermidis
- **Biopsy:** Chronic granulation tissue; no malignancy
- **Blood Work:** Normal CBC, ESR mildly elevated
- **Previous Treatments:** Multiple courses of antibiotics, topical antiseptics, and dressings; minimal improvement

#### Physical Generals:

- Cold intolerance, especially feet
- Profuse perspiration on scalp and forehead
- Anxiety about health and future
- Overweight with sluggish metabolism

**Remedy Selected: Calcarea Carbonica 0/1.****Rationale:**

The remedy is well-indicated for delayed healing, chronic suppuration, and constitutional traits such as chilliness, profuse sweating, and anxiety. The patient's physical and emotional profile matched the remedy picture.

**Treatment Protocol:**

- **Calcarea Carbonica 0/1**, one dose in water potency for 8 days
- Followed by monthly dosing of placebo for 3 months
- Local wound care continued with saline dressings only
- No antibiotics or topical agents used during homeopathic treatment phase
