Abstract

India is one of the secular and religiously diverse country in world. Constitution of India secures the rights and protection of all its citizens by providing wellbeing for all. Indian religious minority communities like Muslim consists 14.2.% of total population followed by Buddhists 0.7%, Christian Community 2.3%, Sikh Community 1.7%, & Jains 0.37% respectively. India is known as welfare state and government have taken many efforts to lead welfare and inclusion of minority communities by adopting welfare and development Programmes in meaningful way. The Constitution of India ensures the equity, equality and social justice regardless of race, religion, caste and class. But somehow welfare of religious ministries India remains a significant area of concern. Religious minority communities often face different challenges in accessing the benefits of welfare especially in socioeconomical recessive communities. The core aim of this paper to access the situation of religious minorities in Indian context and analyses the various welfare programmes in terms of inclusive development of religious minorities in India. The present paper also examine the role of government in terms of empowerment of religious minorities. Paper is based on secondary source of information and explanatory in nature to access the exiting literature to identify the gaps and suggest affirmative mechanisms to lead wellbeing and welfare of religious minority communities in India.

Introduction:-

India is among the world's most religiously inclined nations. As per census 2011 Hindu majority around 79.8%, Buddhists 0.7% Christian 2.3%,Sikh 1.7%, Muslim 14.2%, and Jains 0.37%. India possesses the third largest Muslim population globally, roughly 172.2million, following Pakistan & Indonesia. India's diversity is shaped by variety of intersecting identities, encompassing ethnicity, language, caste, and tribe, along with varying degrees of religious syncretism that challenge traditional conceptions of individuality creation as well as affiliation. Numerous religious minorities in India consequently encounter diverse kinds of intersectional discrimination; for instance, Difficulties faced by minority women are exacerbated for Christians, Dalit Muslims, & other religious minorities that were additionally linguistic minorities or members of indigenous communities (Adivasis). India's religious

minority deal with variety of degrees of violence & prejudice; Muslims are disproportionately affected by communal violence, while Christians as well as Sikhs are less affected. They also face other types of cultural, socioeconomic, and legal discrimination. The Indian Constitution's Articles 15 and 16 protect minorities' rights and forbid discrimination in accordance with sex, caste, race, class, religion, as well as place of birth. It means constitution promotes as well as protects rights of religious minorities too. Article 30 grants religious minorities' authority to found as well as manage educational establishments of their preference. These constitutional provisions are designed to ensure that religious minorities can preserve and encourage their language, religion, and culture, without facing discrimination or marginalization.

In spite of having constitutional safe guard and rights the welfare of religious minorities is a significant and multifaceted issues associated with secular structure of constitutional framework which need to be addressed properly. Country like India known for its diversity, democracy and range of various religions which is a core beauty of the India. The welfare and inclusive development of religious minorities require systematic attention to ensure the wellbeing and safeguard of minority communities. Religious minority community'soften faces many challenges and issues in terms of educational, economical inequalities, social exclusion and political underrepresentation due to which they represent the less in public domain and institutional domain. Government has taken many initiatives to address the issues and challenges to lead welfare and development of the minorities. Scholarships, financial assistance, economic empowerment program, reservation and affirmative actions this are the initiatives of government ensuring protection of rights of religious minorities. But somehow urgent need for hours is to ensure the realization of Indian Constitutional Idea of equality and social justice with positive discrimination for all its citizens' regardless caste and religion.

Objectives of the paper:

- 1. To examine the role government in terms of empowerment of religious minorities in Indian context.
- 2. To analyze statistical situation of Religious Minorities in India from the census 1951-2011.
- 3. To ascertain potential and effectiveness welfare and developmental initiatives of government in order to inclusive development and empowerment of religious minorities in India.
- 4. To idetifythe gaps and suggest affirmative mechanisms to lead wellbeing and welfare of religious minority communities in India.

Methodology:-

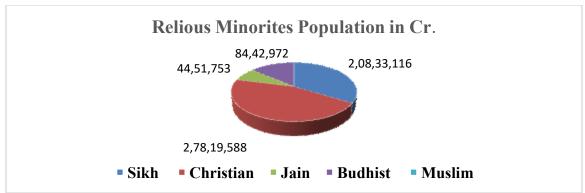

Above table and figure depicts that as per the data captured from the census 2011 the population of Muslim communities higher than other religious minorities its consists 172,245,158, followed by Christian (27,819,588), Sikh population is around 20,833,116 where Buddhist having large population than Jain i.e. 8,442,972 and 4,451,753 respectively.¹

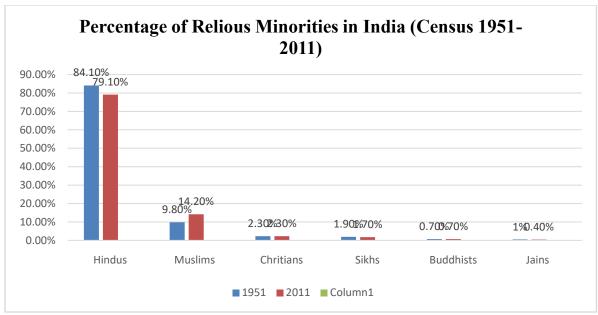

The above table and figure compares the census data of 1951 and 2011 respectively. It has shown that Hindus population percentage declined 5% in census 2011 which was 84.10 % in census 1951. Similarly Muslims population percentage has been raised up to 14.20% in 2011 from 9.80% in 1951. It has been observed that other religious minority's population have not been change much since 1951. It shows that Muslim minority is one of the increasing religious minority group in India compare to other religious minority groups of country.

Geographical Locations of Resinous Minorities in India:

In Indian context, Sikhs, Zoroastrians, Christians, Buddhists, Muslims, and Jains were recognized as religious minorities, collectively comprising around 19% of nation's total population. In rural regions of country during 2009-2010, 11% of families adhered to Islam, including around 12% of the population. Two percent were Christians. Similarly in urban context 13% households were following Islam and 3% households following Christens².

Socio-Economic Situational Analysis of Religious Minorities in India:

According to NSSO, in rural along with urban areas sex ratio of Muslim minorities has been declined in 2004-2005 and 2009 to 2010 respectively. Similarly sex ratio of Christians improved during this period of time. Regarding size as well as population of the household of religious minorities in rural and urban regionsit has been noted that household size of Muslim minorities is larger than other religious minorities. The household's size of religious minorities in rural area is higher than urban areas. As far as concerned livelihood and employability's among the religious minorities it has shown that self-employment is one of the core sources of livelihood among the all religious minority groups. 36% of Sikh population are engaged in agriculture activities as a source of livelihood and almost 46 % of Muslims householdsmain source of income is a self-employed. 43% of the Christians households are from regular wage and salaried employed especially in urban areas. In rural & urban areas, average monthly per capita expenditure is greatest amongst Sikhs, subsequent to Christians. In an average Sikhs spends Rs.1659 while the Muslims spends Rs.980.00.

Literacy and education is one the major concerns for integrated development of any community or groups. Education plays as a key role to empower individuals with social, economic and political point of view. The literacy rate and educational status among the Christians from age of 15 and above is the highest among the both genders in rural and urban areas followed by Sikhs. In relation to unemployment rate had been greatest among Christians (Male-3 percent& Female 6 percent) and for Sikhs it was highest (Male 6% and Female 8%) in urban areas.³

Religious Minorities and Work Category:

The quality of life of any individual or groups is based on what kinds of livelihood source person has. For fulfilling basic needs there should be proper sources of income to maintain standard of living in all the stages of life. However, participation of work by the religious minorities has been divide in to various categories. It means majority of the religious minority groups are involved in unorganized, agricultural and non-agricultural sector for source of income.

The above table shows that 49.9% of total workers from other religions were cultivators, surpassing all-India rate of 31.7%. Next religious groups involved in cultivation is Hindu 33.1% followed by Sikhs 32.4% which again higher than national rate. Muslims and Buddhist are same i.e. 20. % where 29.2% are the Christians having cultivator cataloger. Jains are less in cultivator groups they consists only 11.7%. As far as agricultural labor concerned 37.6% of the total workers among the Buddhist religion which is higher than national average of workers participation followed by other religions in agricultural laborer are 32.6% respectively. The Jain religion group percentage is less (3.3%) than rest of all religious minority groups. In household industry percentage of Muslim workers is around 8.2% which is twice national average of 4.2%. In other workers category 81.7% are Jains which is highest than all religious groups followed by Christians 52.8%, Muslims 49.1% and Sikhs 47.3%. Buddhist having 39.2% workers in other category followed by Hindus 35.5%.

Religious Minorities and Constitutional Safe Guards:

Unity in Diversity constitutes one of beauty of Indian Nation with having different culture and many region groups'comprisingSikhs, Christians, Buddhists, Muslims, as well as Jains. Indian constitution ensures protection of the unity and diversity by providing numerous safeguards and protection to its all citizens including religious minorities in the country.

For welfare of the religious minority groups there are many flagship programs introduced by the government to lead inclusive and integrated development of religious minorities in India. But somehow these efforts need to be chanalize in effective manner right from the top to bottom level. So that each deserving minority group will get benefited without any hurdles. Lack of Execution and monitoring of the programmes and policies welfare of the religious minorities remained challenged.

Overview of 15 Points Program for Religious Minorities:

Welfare of Religious Minorities is one of core agenda of government, hence, many welfare initiatives have been undertaken by central government assuring all round welfare along withcomprehensive advancement of religious minorities in India. Central sponsored strategiesas well as flagship programs made by the government to enhance the quality of life and improve socio-economical standard of minority communities especially socio-economically disadvantaged minority groups. In 2006 government has introduced Prime Minister's 15points program for catering needs of religious minorities in India. Through this initiatives districts where 25% population belongs from minority communities such districts called as Minority Concentration Districts (MCD).

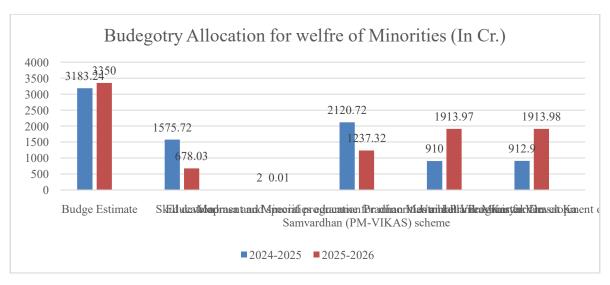

The above table and figures shows the budgetary allocation for welfare of minorities from previous financial years of 2024-2025 and current financial year 2025-2026. It reflects that in 2025-2026 estimate budget is increased with 5% than previous budget. Rs. 3,183.24 Cr. Estimated in 2024-2025 and Rs. 3350.00 Cr. Estimated in current financial year 2025-2026. But educational budget for minorities has been decreased against the last budgetary allocation. In 2024-2025 total budgetary allocation on education was Rs. 1575.72 Cr. this year it has decreased up to Rs.678.03. Cr. It is sharp dip in education budget for minorities in 2025-2026. Similarly budget allocation for Madrassa and Minorities education continues decreasing against last budget. Rs.2.0 Cr. allotted in 2024-2025 for Madrasa and Minority education but in 2025-2026 only Rs.0.01 Cr. has been allotted which are very low compared to previous budgetary allocation. Even skill related and livelihood related program budget decreased up to Rs. 1237.32 Cr. in 2025-2026 against Rs. 2120.72 Cr. in financial year 2024to2025. In current financial year 2025to2026 there is significance budgetary hike in other schemes like Umbrella Program &Pradhan Mantri Jan VikasKaryakramfor Advancement of Minorities.

Suggestive Mechanism for overall welfare of Minorities:

- Constitutional safe guards for minorities need to be protected on priority basis.
- Strengthen the mechanisms for execution of welfare and development programmeto enhance socio-economic status of minority communities.
- Create the appropriate system through which proper monitoring and constant assessment can be done on various welfare programs to ensure the benefits will reach to unreach without any hurdles.
- Proper publicity and awareness generation programmes on various welfare Programmes need to be organized at local level.
- Make easy and affordable mechanism to assess the basic fundamental needs like quality education, health and livelihood opportunities to minority communities without any discrimination.
- Community, Government authority and Civil Society need to come together to empower the minority communities.
- Uphold the constitutional values of social justice, non-discrimination, equity and equality to ensure the inclusive welfare and development of minority communities.
- Follow the principle of Secularism and ensure the Leaving No Religious Minority Community Behind.

Conclusion:-

India is a welfare state and every state has to ensure their constitutional responsibility to welfare and development of its all citizens devoid of any discrimination on basis of Caste, Race, Religion, Gender, as well as Class. Each on has equal right to enjoy the constitutional right by having equal access of health, participation, employment and education in public life. The main concerns of welfare of minority communities is social exclusion, lack of representation in public domain and religious tolerance creates the environment where the welfare of religious minorities remained challenge.
