While these frameworks provide valuable snapshots of immediate political situations, they often look at human society as an isolated entity. 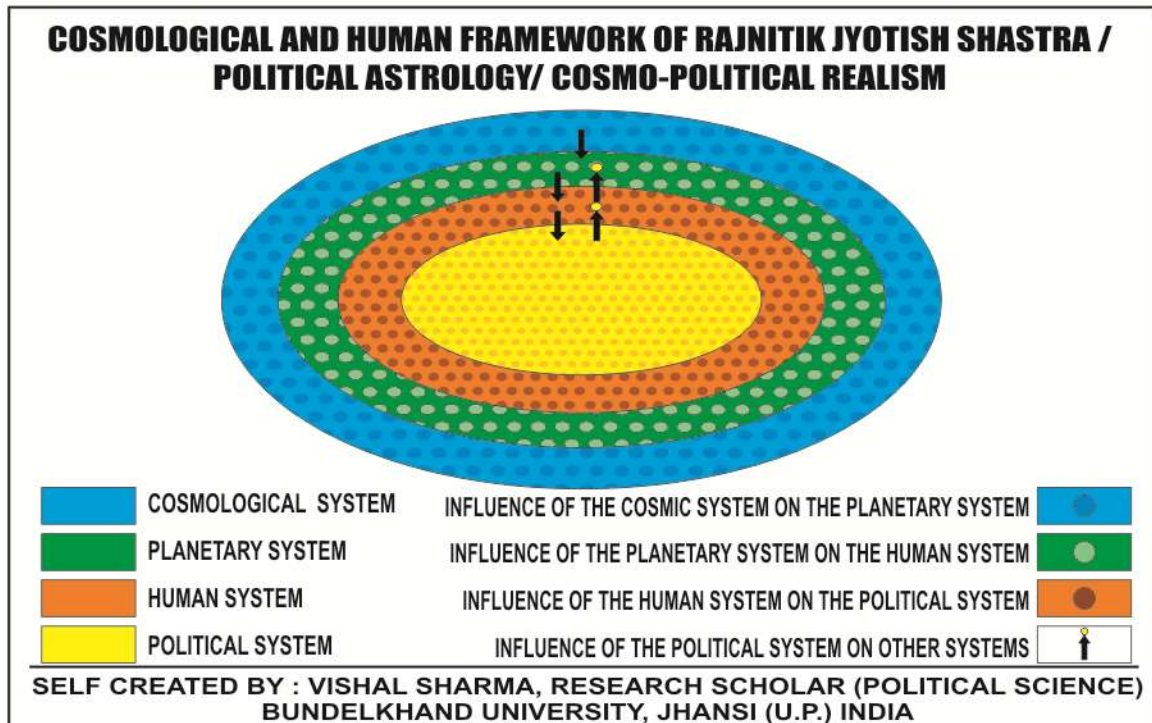

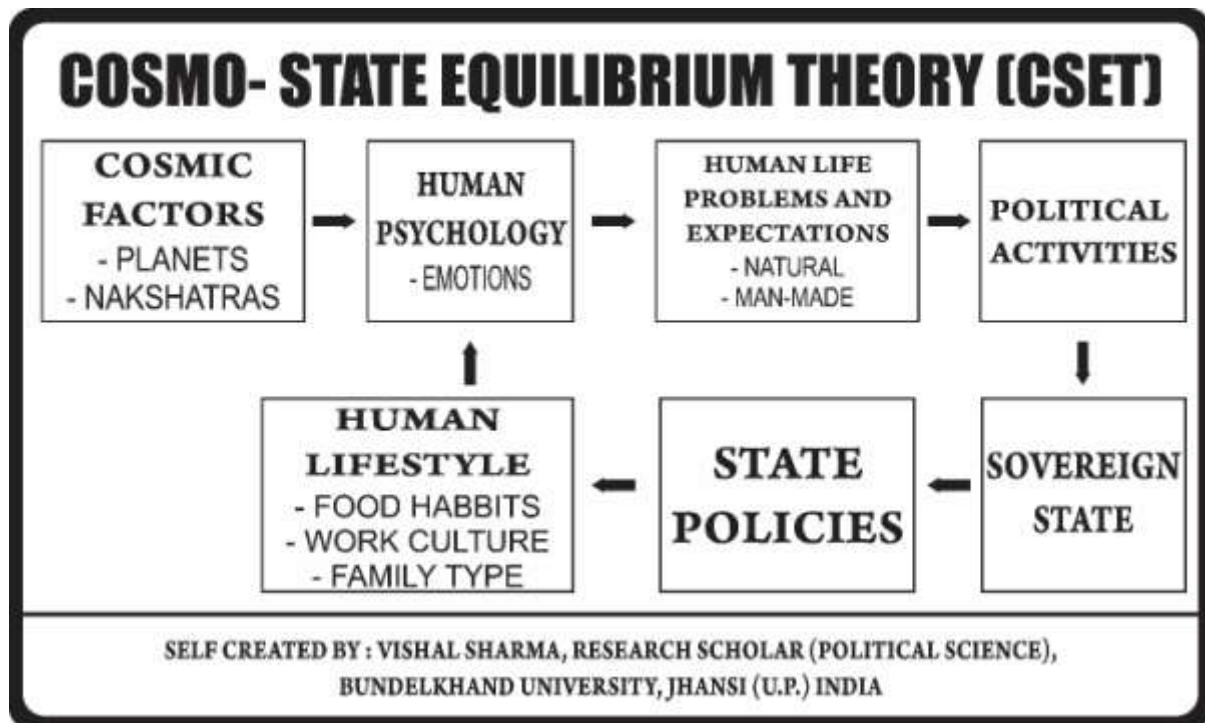
- **SE (State Equilibrium):** The state of optimal governance, characterized by maximum systemic efficiency and long-term political stability.
